To Whom It May Concern:

This letter is in regard to the Delta County Sheriff's Office review, changes in processes and requirements for bail bonds in Delta County. Effective May 1, 2013 in order to be recognized as a bail bonding company by the Delta County Sheriff's Office, all bail bonding companies must submit the following information:

- 1. Letter to Sheriff of Delta County requesting approval as a bonding company.
- 2. Proof of incorporation as a bail bonding company, together with Certificate of Good Standing.
- 3. Active Proof of Bail Bond Training (Section 1704.152 Subsection (a) (4) B, Occupation Code).
- 4. Surety proof in the form of a financial statement with a minimum of \$250,000 non-exempt assets which are unencumbered by lien or claim in available surety.
  - a. Annual sworn financial statement of all sureties filed with the Sheriff on or before May 1 of each year. Sworn financial statement must include the following language:

- b. Property claimed as a part of any sureties may not have exemptions such as homestead exemptions, and may not be encumbered by any lien or claim
- 5. Oath of Surety (Form DSO1)
- 6. Financial Statement Verification (Form DSO2)
- 7. File with the County Clerk a power of attorney (Form DSO3) designating and authorizing the named agent, agents or attorney of such corporation to execute such bail bonds and thereafter the execution of such bail bonds by such agent, agents or attorney, shall be a valid and binding obligation of such corporation. Such agents shall meet all requirements under the Texas Occupation Code relating to bail bond sureties.
