

MEMORANDUM OF UNDERSTANDING BETWEEN DELTA COUNTY SHERIFF'S DEPARTMENT AND COOPER ISD POLICE DEPARTMENT

This Memorandum of Understanding between the Delta County Sheriff's Department (DCSO) and the Cooper ISD Police Department (CISD PD) is effective on the date appearing above the signatures of the parties.

RECITALS

The Cooper Independent School District has established a Police Department pursuant to the authority granted by, and in accordance with, the Texas Education Code, Section 37.081. Cooper ISD PD peace officers commissioned under section 37.081 have the jurisdiction set forth in said statute.

Texas Education Code, Section 37.081(g) requires school District Police Departments to enter a Memorandum of Understanding ("MOU") with law enforcement agencies with which they have overlapping jurisdiction that outlines reasonable communications and coordination of efforts between the departments. This MOU is to outline reasonable communications and coordination of effort between DCSO and CISD PD.

TERM

This MOU shall remain in effect for one (1) year from its effective date. It shall be automatically renewed for successive one (1) year terms unless either party gives notice in writing to the other party at least thirty (30) days prior to the end of the term of its intent not to renew.

PRIMARY RESPONSIBILITY AND COOPERATION

1. Vehicle Collisions and Traffic Enforcement

CISD PD will investigate all traffic collisions which occur on CISD property between the hours of 7:30 am and 4:00 pm on normal school days and during special CISD events. CISD PD will investigate collisions on school property after 4 pm if a CISD PD officer is on the scene and not otherwise occupied with security functions. DCSO will investigate all other collisions according to state law. DCSO will provide crime scene or collision scene assistance as available. CISD PD will be made aware of traffic collisions involving buses transporting CISD students. In most cases, CISD PD can assist DCSO officers in the care of the students and in identifying students, arranging alternative transportation, notification of parents, etc. If a non-reportable bus collision CISD fleet vehicle collision occurs during normal CISD hours, a CISD PD officer will conduct the investigation and make a report.

2. Incidents at CISD bus stops or off-campus incidents involving CISD students.

DCSO will respond to calls concerning students at bus stops and other locations. CISD PD will be made aware of the call by radio or cell phone and, if available, will respond to assist DCSO officers. However, the primary unit will be the DCSO officer dispatched.

3. Calls or sightings of children out of school during school hours.

DCSO and CISD PD will work together in detaining any children and returning them to their proper campus. CISD PD will be the primary agency responding to this call for service. DCSO may assist if needed. Responsibility for the call will be determined prior to the call being dispatched to DCSO officers. DCSO officers shall assume, upon receiving a call concerning children out of school during school hours, that there are no CISD PD officers available to take the call.

4. Citations

Traffic citations and any other Class C citations issued by CISD PD may be processed through the appropriate judicial court.

5. Transporting prisoners.

DCSO and CISD PD will each be responsible for transporting their respective prisoners. Either department may assist as the secondary unit if a unit is available.

6. Investigations.

A. Incidents at CISD facilities during school hours.

CISD PD will respond to and follow-up on calls for service which occur on their facilities between the hours of 7:00 am and 4:00 pm on normal school days. This includes follow-up of all criminal incidents. Either department may be called upon to assist the other if the situation requires a level of expertise or equipment, which is not immediately on hand by the requesting department. In these incidents on CISD property, the DCSO officer may act as an assisting officer and the CISD PD officer will be the primary officer.

B. Incidents at CISD facilities after school hours.

DCSO officers will be dispatched and will make a report if appropriate, for calls for service which occur on CISD facilities during all hours other than 7:30 am to 4:00 pm Monday through Friday on normal school days if a CISD PD officer is unavailable.

7. Communications/Dispatch Services

DCSO shall provide communication dispatch services to CISD PD through licensed communications operators in accordance with TCOLE regulations and standards. DCSO will include CISD PD on its communications networks including radio dispatch. CISD PD will be responsible for the expense incurred in acquiring the necessary radio equipment. DCSO and CISD PD will cooperate in the development of appropriate protocols for radio communications equipment. Annual fees will be agreed upon by the administration of CISD and Delta County subject to potential salary increases and inflation.

8. TCIC/NCIC Information

Pursuant to Texas Department of Public Safety Rules and Regulations when an approved TLETS Agency (DCSO) makes criminal justice information available to another criminal justice agency (CISD PD), the TLETS agency must have on file a "non-terminal" agency agreement between the parties. Under the terms of such agreement which shall be in place prior to the beginning of operations under this MOU, and at all times during such operations, DCSO will make available to CISD PD access to TCIC/NCIC data as necessary and appropriate for CISD PD in carrying out its duties. A copy of the non-terminal agency agreement is attached hereto as "Attachment A". CISD PD shall ensure its officers have any necessary training and certification for access to said data.

9. Notifications

DCSO will notify by email or mailbox at DCSO designated "CISD PD" personnel of any serious incidents that occur on CISD property and which were reported to DCSO. DCSO communications will notify the CISD PD of any major event that occurs in the county of Delta that may have an impact on school campuses in the area.

10. Training

Both departments will share training opportunities which may be available and of interest to either department. Training expenses will be paid as appropriate and consistent with others attending the training.

11. Complaints/Compliments

Any citizen complaints/compliments to either department about the other will be forwarded to the appropriate Chief/Sheriff or his designee.

12. Exceptions

Exceptions to the provisions in this MOU may be made as necessary to carry out the intent of the parties upon agreement of the Chief/Sheriff of both departments.

13. Review of this MOU and amendments

The Chief/Sheriff of both departments shall meet as often as necessary and no less often than annually to review this MOU and to prepare recommended amendments to both parties.

14. Indemnification Clause

The CISD PD shall indemnify and hold harmless DCSO, its officers, agents, and/or employees from all suits, actions, losses, damages, claims or liability of any character, type, or description, including without limiting the generality of the foregoing, all expenses of litigation, court cost, and attorney's fees for injury or death to any person, or damage to any property, received or sustained by any person or persons or property, arising out of, or occasioned by the acts of DCSO its officers, agents and/or employees during the course of its performance of its obligations and duties pursuant to the terms of this Memorandum of Understanding.

15. Expenditures

Any mutually agreed upon expenses incurred by or attributed to CISD PD shall be invoiced by the DCSO and forwarded to CISD PD.
