10. Discuss and take possible action to provide an update on and status of a request from a landowner regarding a materials donation for road improvements on CR 1150, situated in Precinct 1, that was acted on by the Commissioners Court on October 26, 2020 - Linda Richardson, Property Owner

The Court received comments from a landowner, Linda Richardson, regarding a materials donation that was approved in October, 2020, but later refunded to the landowner. Commissioner Morgan Baker did not believe the amount of materials donated was sufficient enough to perform the work that was requested. Commissioner Baker explained his perspective to the landowner. The landowner asked the Court to make sure that this work was performed. The County Judge explained that he had reached out to legal counsel with the Texas Association of Counties (TAC) regarding the issue and cited Chapter 252 of the Texas Transportation Code which outlines the systems of county road administration and the duties and of an Ex Officio Road Commissioner, which grants the County Commissioner the authority to determine the condition of the public roads in the commissioner's precinct, determine the character of work to be done on the roads, and direct the manner of grading, draining, or otherwise improving the roads. The County Judge explained that Commissioner Baker had the authority under the Texas Transportation Code to determine whether or not he wished to perform the work. County Attorney Edgar J. Garrett was present and also agreed. Mrs. Richardson left the meeting and no action was taken.
