Once abandoned, the property interest will vest in the owners of properties in above surveys that abut the abandoned the platted road named Estelle Street between Block 16 and Block 17 in original town plat of Enloe, Texas, 75411 in proportion to his property frontage and to expand to the center-line of the road on each side (in accordance with Section 251.058(b) of the Texas Transportation Code). The owner of said properties is Cody Lane King, 4691 FM 198 West, Enloe, Texas 75441.
